## INVITITING APPLICATIONS THE POST OF MEMBER ON CONSUMER GRIEVANCES REDRESSAL FORUM, GOVERNMENT OF GOA

- 1. The Government of Goa has constituted the Consumer Grievances Redressal Forum in the State for Redressal of the grievances of consumers of the Distribution Licensee viz. the Electricity Department, Government of Goa under sub-regulation (1) of regulation 7 of JERC (Forum for Redressal of Grievances of the Consumers) Regulations, 2019.
- 2. The Electricity Department, Government of Goa being licensee has to appoint a Member on the Consumer Grievances Redressal Forum, with its office at Vidhyut Bhavan, Vasco Goa.
- 3. The qualifications and experience for appointment of Member shall be as follows:-
- 4. Member: Member shall be a retired officer of any State/Central Power Sector Department's/PSU not below the rank of Executive Engineer or equivalent possessing degree in electrical/mechanical/ electronics/computer engineering and having atleast 15 years' experience preferably in matters relating to the distribution of electricity or a serving officer of the distribution licensee of the same jurisdiction not below the rank of Executive Engineer(Not below the rank of Assistant Engineer in case of Lakshadweep and Andaman & Nicobar islands).
- 5. The candidate who is a resident of Goa shall be given preference.
- 6. The Member shall be entitled to receive a consolidated remuneration of Rs. 60000/- per month. He/She shall also be entitled for TA/DA while out on duty as eligible to Class I officers of the rank of Deputy Secretary of Level 12 in the Central Government. He/She shall also be entitled for 12 days Casual Leave in a calendar year.
- 7. The appointment will be for a term of 03 years from the date of appointment which may be extended further for a 3 years term with the prior approval of the Commission subject to the upper age limit of 65 years.

- 8. The applications giving the following data and accompanied by self-attested copies of the supporting documents/ testimonials and two references from responsible person of the area duly addressed to the Chief Electrical Engineer, must reach in the office of the Chief Electrical Engineer, Electricity Department, Government of Goa, Vidyut Bhavan, 3rd Floor, Panaji—Goa,403001, on or before 22/09/2023

  - 11. The candidates willing to apply for appointment as Member shall have to resign or opt for voluntary retirement from the regular government service.
  - 12. All self- attested copies of educational and experience certificate must be enclosed with the application, failing which application is liable to be rejected.
  - 13. Application received after due date i.e. 22 09 2023 or incomplete applications shall not be entertained.
  - 14. The Department of Electricity reserves right to cancel the selection process at any stage without assigning any reason.
